#### <u>Dale Casper - Lakeshore Technical College</u>

- Dale Casper has been at LTC for 30 years, always in Grounds and Receiving. He goes above and beyond
  to make our campus less hazardous for our staff, students, and visitors during the year. Dale was
  responsible for implementing our salt bins at our entrances/exits at all of our 6 Cleveland Campus
  Buildings. He works with the Wisconsin DOT, Manitowoc County, and a local contractor to secure and
  store salt for our winter month needs. He works diligently to ensure equipment is in working order,
  from the shovels to the tractors to the spreaders. Dale drives around the campus first thing in the
  morning looking for hazardous areas.
