### "The Campus Safety & Security Ecosystem" | Dan Pascale, Margolis Healy

Started with a grant from Homeland Security in 2015 the Wisconsin Cyber Response Team is a partnership between the WI National Guard Cyber Forces and a volunteer group of technology leaders in SLTT, education, federal and private industry. This session will align the experiences of the WI-CRT with the five functions of the NIST Cybersecurity Framework to provide attendees with information necessary to reduce the likelihood of a successful cyberattack and what to expect from the WI-CRT in the event that a cyberattack is successful.
