Attendees will examine practical AI applications already in use by safety professionals and emerging capabilities. Participants will walk away with a clearer understanding of how AI can add value in safety operations and how to evaluate and implement AI tools responsibly, ethically, and with a risk manager's mindset.

Free Speech in Higher Education: Rights, Exceptions, and Reducing Risk | *Josh Vollendorf, Gateway Technical College*

This workshop reviews First Amendment protections for free speech on public college campuses, explains why strong safeguards are vital for academic inquiry, and outlines narrow exceptions like true threats, severe harassment, or substantial disruption. Participants will explore key Supreme Court cases, analyze campus scenarios via case studies, and learn practical strategies to develop compliant policies, prevent viewpoint discrimination, and minimize costly legal and reputational risks.
